Additionally, your transaction security information is processed through cookies to ensure the operation of the website and information processing security. In this context, if you visit the 10th Turkish World Cardiology Association Congress website, mandatory and functional cookies can process information such as the pages visited and the number of views, the browser and IP used for access, and system settings information. This data is never used by us to identify you personally and is processed for legitimate interests to ensure the use of our website and information processing security.
